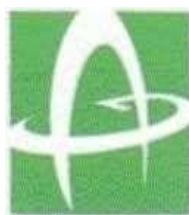

- For Reimbursement purpose Vendor can submit non GST Invoice in his name along with GST Invoice from DSC Provider.
- Payment will be made by way of normal banking channels.
