Aavantika Gas Ltd. (AGL) is a Joint venture of GAIL & HPCL for implementation of City Gas projects in Indore, Ujjain, and Pithampur & Gwalior. AGL is in to distribution of natural gas for transportation, industrial, commercial and domestic consumers.

The Petroleum and Natural Gas Regulatory Board (PNGRB) has issued regulations titled PNGRB Third Party Conformity Assessment Regulations 2015 based on which the CGD entity is required to carry out the audit of its infrastructure after a defined period. As per this regulation, ERDMP audit based on ERDMP Regulations, 2010 is required to be conducted once in five years.

ERDMP (Emergency Response and Disaster Management Plan) regulation was notified by PNGRB in 2010. ERDMP regulation provide brief description pertaining to pre-emergency planning, emergency mitigation and preparedness measures and response procedures, emergency organization responsibilities, reporting of the incident and emergency recovery procedures.

1. SCOPE OF WORK:

As per the scope of audit following areas will be covered:

- Steel and MDPE Pipeline Network
- CNG Stations (Mother Stations, Online Stations, DBS & Daughter Stations)
- PNG Customers (Domestic, Commercial & Industrial)
- Any other AGL asset
- Isolation Valve Chambers
- Documents related to CGD business.
- Hydrogen facility at AGL

- Scope of work also include Hydrogen blending at Indore location. The complete set-up which includes Hydrogen carrying Pipeline, Metering skid, Storage or any other component related to Hydrogen Blending (Inside and outside AGL premise) to be covered in the audit.
- For Audit man-days, remuneration, competency & experience of auditor/lead auditors', Audit schedule guidelines and regulations issued by PNGRB applicable for ERDMP audit to be followed.

- The scope and quantum of audit shall be as per the guidelines/criteria issued by PNGRB to the TPIAs to carryout ERDMP audit of Aavantika Gas Limited in accordance to PNGRB ERDMP regulations. The TPIA shall carry out the audit of assets of AGL to review the compliance of the same as per the prevailing ERDMP regulations.
- Bidder should have valid/active empanelment letter received from PNGRB to carryout technical audit in accordance to PNGRB ERDMP Regulation. Submission of documentary evidence / empanelment letter to be done by the bidder.
- Bidder should comply The Petroleum and Natural Gas Regulatory Board (PNGRB) regulations titled PNGRB Third Party Conformity Assessment Regulations 2015 dated 17/04/2015.
- Bidder should comply NABCB (National Accreditation Board for Certification Bodies) guidelines – “Competence requirements for Inspection Bodies for accreditation against PNGRB Regulations” to carry out the ERDMP audit of Aavantika Gas Limited.
- The TPIA shall appoint a principal coordinator who will be responsible for all the activities. Detail plan to complete the subject activity to be shared with AGL which includes visits to the sites, review of documents/records.
- The TPIA shall depute adequate number of manpower with required competency to carry out the audit in accordance to NABCB Guidelines.
- Draft report, final report & certificate to be submitted by TPIA within required time frame of contract period.
- The TPIA shall follow the “Guidelines for Remuneration for Auditors, Professional Charges for TPIA issued by PNGRB on 17th Jun 2025 for audit fees to auditors.
- The TPIA must have a valid empanelment letter from PNGRB for conducting ERDMP audit. The validity of empanelment of TPIA should be 15 weeks from the bid due date.. The bidder and the auditor team should have minimum experience of conducting at least three numbers of audits till now.
- The auditors must have minimum experience of 15 years in Oil & Gas sector, experience in CGD industry will be preferred. TPIA will share brief profile/CV of the auditors to AGL and take approval. Audit dates to be finalize after confirmation by AGL. In all cases final decision will be given by AGL. However, entity have to follow Man-days matrix and other regulations related to ERDMP audit issued by PNGRB.

2. BID EVALUATION CRITERIA:

1. Bidders should have valid/active empanelment letter received from PNGRB to carry out technical audits and certification in accordance with PNGRB ERDMP Regulation. Validity of the empanelment letter should be at least 15 weeks from the bid due date.
2. The bidder should have experience of conducting minimum 03 numbers of ERDMP audit in any pipeline division (City Gas Distribution Pipeline/ Natural Gas Pipeline/Cross Country Pipeline, Petroleum Product Pipeline) in last 05 years.
3. Auditor should have experience of conducting minimum 03 nos. of audit for any PNGRB Technical Regulation (IMS, T4S, ERDMP) with overall technical experience of 15 years preferably in Oil & Gas Sector.

- If the quoted amount of two or more L-1 ranked bidders are same, then bidder whose turnover as per last filed ITR is more will be considered for award.

5. CONTRACT PERIOD:

The contract period to carry out the technical audit as per PNGRB ERDMP Regulations along with submission of final report & certificate will be 14 weeks from the date of issue of LOI/PO.

6. PRICE REDUCTION SCHEDULE (PRS):

In case, the vendor fails to complete the work/services within stipulated period then unless such failure is due to force majeure, there will be reduction in contract price @ ½% for each week of delay or part thereof subject to maximum of 5% of Order Value (Excluding Taxes and Duties).

In case of delay, the invoices shall be submitted after deducting the price, as above, due to delay.

However, PRS shall not be applicable, in case the delay is for the reasons beyond Contractor's control, to be established by EIC (Engineer-in-charge).

7. PAYMENT TERMS:

100% payment will be done after carrying out physical audit and submission of final report & certification.

Payment shall be made within 15 days after submission and acceptance of Reports / Certificate by Engineer-In-Charge.

8. APPLICABILITY OF LAW & JURISDICTION:

The RFQ shall be governed and interpreted in accordance with the applicable laws of India and Courts at Indore (Madhya Pradesh) shall be exclusive Jurisdiction.

9. OTHER TERMS & CONDITIONS:

- a) The offer should remain valid for 2 months from the bid due date / extended due date of tender.
- b) The prices once quoted shall not be changed whether resulting or arising out of any subsequent technical / commercial clarifications sought regarding the bid and even if any deviation or exclusion may be specifically stated in the bid.
- c) Bidder is advised to quote strictly as per scope & terms and conditions of bid document and not to stipulate any deviation / exceptions.
- d) Purchaser reserves the right to accept or reject any or all bids received at its absolute discretion without assigning any reason, whatsoever.
- e) Bids complete in all respects should reach on or before the BID DUE DATE AND TIME. Fax / Telegraphic/ E-Mail bids shall be rejected.
- f) In absence of requisite documents requested by AGL in this Tender, AGL reserves the right to reject the bid without making any reference, what so ever, to the bidder.
- g) The bidder is advised to visit and examine the site of works and its surroundings and obtain for himself on his own responsibility, all information that may be necessary for preparing of the bid and entering into contract. The cost of visiting the site shall be at bidder's own expenses.
- h) At any time prior to the bid due date, Purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the Bid documents, by issuing corrigendum.
- i) Any corrigendum thus issued on AGL's website shall be part of the Bid documents and shall also be notified in writing by email to all available prospective bidders, who have earlier received the Bid documents. Prospective bidders shall promptly acknowledge receipt of each corrigendum by email to the Purchaser.
- j) The Purchaser may, at its discretion, extend the bid due date in order to allow prospective bidders, a reasonable time to furnish their most competitive bid taking into account the amendments issued.

- k) The bid shall remain valid for 2 months from the bid due date. Purchaser may reject a bid which is valid for a shorter period being non-responsive.
- l) Any bid received by the Purchaser after the deadline for submission of bid will be declared "Late" and rejected and may be returned unopened to the bidder at the sole discretion of the Purchaser.
- m) The Purchaser will open all bids in the presence of Bidders' representatives who choose to attend, at the time, on the date and place (as specified in IFB). The Bidders' representatives, who are present, shall sign a register evidencing their attendance, if so required by the Purchaser.
- n) During evaluation of the bids, the Purchaser may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing, and no change in the prices or substance of the bid shall be sought, offered, or permitted.
- o) The Bidder whose bid is found substantially responsive shall be invited to attend the opening of price bid. Such bidders may be required to attend the price bid opening at a short notice. The place, date and time of price bid opening will be informed to all such Bidders. The Bidders' representatives who are present shall sign a register evidencing their attendance.
- p) **ARITHMETIC CORRECTIONS**
 - I. The bids will be checked for any arithmetical errors as follows if any, will be rectified on the following basis:
 - II. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail, and the total price shall be corrected;
 - III. If there is a discrepancy between words and figures, the amount in words will prevail;
 - IV. If the bidder does not accept the correction of errors, its bid will be rejected and the bid security will be forfeited.
- q) Quotation received after the due date and time, are liable to be rejected. Quotations through Email / Telex / Fax / Photocopied are not acceptable.
- r) Bidders must abide to follow all statutory norms and regulations & labor laws and comply with all as applicable.
- s) Guaranty / Warranty certificate for all supplied items to be provided by the bidder.
- t) After verification of the received final product, if any item found faulty or defective than the same will have to be replaced by the bidder without any additional cost implications.
